

KDHA Kansas Legislative Report

March 17, 2022

March Madness has reached Topeka as most committees wrapped up their business for the year. Committees collectively recommended dozens of bills to move forward in the process while hundreds of other bills not receiving action will effectively be lost. There are just two weeks left before the April break, with next week planned for debates on the House and Senate floor and the final week of the month reserved for conference committees to reconcile differences between House and Senate versions.

Despite the committee work, the Senate and House kept busy on the floor debating bills. The Senate debated and passed its mega budget bill while the House prepares for its budget debate next week. The Senate also passed a redistricting map for state Senate districts while a handful of House redistricting maps surfaced too. On the tax side, the House Committee on Taxation recommended a bill that is assumed to be the House's attempt to reduce the state sales tax on food.

The Senate Committee on Public Health and Welfare held a hearing on HB 2386, which establishes requirements for the payment and reimbursement of dental services by a dental benefit plan. In the hearing, the Kansas Dental Association testified in support of the bill with no opposition and Delta Dental as a neutral. The next day, the committee approved the bill and sent it to the Senate floor where it may be debated next week.

This was the final week for the health committees to meet. Beyond HB 2386, the Senate committee dedicated the balance of its meetings to review legislation pertaining to licensing of massage therapists and bills related to COVID treatment. On the House side, the Committee on Health and Human Services held a hearing related pharmacists' scope of practice.

Later in the session, the Health Conference Committees will meet to review previously passed health bills that have differences between the House and Senate versions but the standing health committees should be finished for the session.
