

KDHA Kansas Legislative Report

February 3, 2022

This week session saw an unexpected turn as the snowstorm shut down the Legislature on Wednesday. The Senate opted to stay closed for the rest of the week while the House returned on Thursday for a handful of committee meetings. Monday and Tuesday saw plenty of action and new bills continue to flood in the doors. Next week promises to offer dozens of committee meetings with packed agendas making up for the snow days and preparing for Turnaround deadlines.

With the calendar officially turned to February, each week grows more intense. Most bills must be passed by the February 24 Turnaround deadline, essentially meaning committees have just two weeks to hold hearings and recommend bills. Meanwhile budget subcommittee continue to review agency budget proposals as the House considers the Economic Development Incentive Bill that was passed by the Senate last week.

The snow closure postponed the scheduled consideration of SB 129 (related to dental therapy) by the Senate Public Health & Welfare Committee. SB 129 had a hearing last session and is eligible for action at any time through Turnaround. The committee is expected to reschedule this for Monday, February 7 at 8:30AM.

Likewise, the Senate committee has not taken any action on SB 121. This is a Kansas Dental Association bill introduced last session that proposes to allow the Kansas Dental Board to take disciplinary action against a dental licensee for failing to perform an examination of a patient prior to diagnosing and correcting malpositions of human teeth or initial use of orthodontic appliances.

At this time, the House Health and Human Services Committee has not scheduled a hearing for HB 2545 or HB 2546, both introduced by the Kansas Dental Association. HB 2545 aims to define non-covered dental benefits under health insurance plans while HB 2546 requires health

benefits plans that provide dental care services to provide the same benefits regardless if the claim is part of the provider network.
